#### NOTES TO THE FINANCIAL STATEMENTS

#### 1. GENERAL INFORMATION

AB City Service (hereinafter - "the Company") is a public limited liability company registered in the Republic of Lithuania on 28 January 1997.

The Company controls corporate group, engaged in provision of facility management and integrated utility services in Western, Central and Eastern Europe. The City Service group is the market leader in facility management and integrated utility services in the Baltic States. It provides services in the following cities and regions: in the municipalities of Vilnius, Kaunas, Klaipėda, Šiauliai, Alytus, Utena, Marijampolė, Palanga, Trakai, Širvintos, Radviliškis, Neringa, Varėna, Kazlų Rūda, Vilkaviškis, Šilutė, Panevėžys and Pagėgiai in Lithuania; in Poland; in Spain; in Riga and separate regions in Latvia; in St. Petersburg and Stavropol in Russian Federation.

#### 1.1. ACTIVITIES

City Service group provides facility management; maintenance and repair of engineering systems; management and renovation of energy resources; technical and energy audit of buildings; maintenance and cleaning of territories and premises. The most important buildings segments, administered by the City Service group are: residential apartment buildings; commercial buildings; public buildings; industrial buildings. The total area of buildings under the management of the Group is 32.1 million sq. m. at present.

City Service group carried on implementing confirmed strategy and was further looking for organic growth opportunities in Central and Western Europe, Latvia and Lithuania as well in the first half of this year. Extensive negotiations with potential foreign and local companies regarding their acquisition, reorganization and implementation according to the Group's business model and standards were carried out.

The Company's subsidiary in Spain acquired company Administraciones Santa Pola SL, rendering residential facility management services in the region of Alicante. In this way, the Company entered into residential facility management market in Spain.

The Company also acquired 100 (one hundred) percent of shares in UAB Mūsų butas, which renders residential facility management services in Šiauliai.

At this reporting period, when the Company completed the shares purchase - sale agreements of UAB Baltijos liftai and UAB Ecoservice (including its subsidiaries), the Company and its subsidiaries had fully implemented the requirements of Article 4.84 of the Civil Code of the Republic of Lithuania, establishing that the entities, administering objects of common use in buildings apartment may not be engaged in or related to heat, electricity, gas or water suppliers, as well as to entities, providing waste transportation and elevators technical maintenance services, in case they operate in the territory of the same municipality. These changes in operational environment will enable Company to continue successful development of residential facility management services.

### 1.2. SHARE CAPITAL OF THE COMPANY

The share capital of the Company is LTL 31,610 thousand as of 30 June 2014. It is divided into 31,610 thousand ordinary shares with the nominal value of LTL 1 each. All shares of the Company are paid up.

The Company does not have any other classes of shares than ordinary shares mentioned above, there are no any restrictions of share rights or special control rights for the shareholders settled in the Articles of Association of the Company. No shares of the Company are held by itself or its subsidiaries. No convertible securities, exchangeable securities or securities with warrants are outstanding; likewise, there are no outstanding acquisition rights or undertakings to increase share capital.

On 30 June 2014 all 31,610 thousand ordinary shares of the Company are included into the Official List of NASDAQ OMX Vilnius Stock Exchange (ISIN Code of the shares is <u>LT0000127375</u>). Trading Code of the shares on NASDAQ OMX Vilnius Stock Exchange is CTS1L.





#### Investments and other changes during the six months of the year 2014

On 3 January 2014, the Company acquired 100% shares of Cleaning Partner Sp. z.o.o. The value of the contract is PLN 5 million.

On 16 January 2014, the Company through a subsidiary acquired 100% shares of City Service Grupa Techniczna Sp. z.o.o. The value of the contract is PLN 5 thousand. At the moment City Service Grupa Techniczna Sp. z.o.o renders technical maintenance services in Poland.

On 21 February 2014, the Company signed an agreement on sale of UAB Ecoservice shares. On 31 March 2014, share transfer transaction was closed, after Competition Council authorized the transaction and other conditions of the transaction were fulfilled. Value of the transaction is LTL 56.6 million (EUR 16.4 million), including dividends amounting to LTL 5.2 million (EUR 1.5 million) paid to the Company. Shares of UAB Ecoservice are transferred to UAB AWT Holding. Control and controlling interest of the later shall belong to 75% share owner BaltCap Private Equity Fund II, with remaining 25% shares in Company's possession which were accounted as investment in associated company.

On 10 April 2014, considering the structural changes in Poland operating market subsidiaries, as well as the fact that the subsidiary Cleaning Partner Sp. z.o.o. had significant undisclosed financial obligations to employees, 100 percent of Cleaning Partner Sp. z.o.o shares have been sold.

On 25 April 2014, continuing the process of unbundling the activities, the cleaning activities from UAB Naujamiesčio būstas have been transferred to separate newly established legal entity. Cleaning activities from UAB Naujamiesčio būstas were transferred to UAB Miesto valymas (the Group owns 100% of shares), legal entity code is 303297727.



On 30 April 2014, the Ordinary General Meeting of the Shareholders of the Company has been held. The shareholders approved the audited financial statement for the year 2013, distributed the Company's profit for the year 2013, a new member of the Board was elected. Shareholders also approved Ernst & Young Baltic UAB, company code 110878442, as an audit company for the performance of the audit of the Company's consolidated financial statements for the year 2014 and for the evaluation of the Company's consolidated annual report. The meeting has also established the payment conditions for audit services. During the meeting the Company decided to purchase its own shares and to withdraw from activities in St. Petersburg and Stavropol.

On 14 May 2014, Company through a subsidiary has acquired Administraciones Santa Pola S.L. that manages 211 thousand sq. m. of residential facilities in Alicante province, in Spain. Revenues of acquired company were EUR 115 thousand in 2013, and subcontracted turnover reached EUR 1.4 million. The company was acquired for EUR 90 thousand.

On 26 June 2014, Company's subsidiaries in Poland - City Service Polska Sp. z o.o. and City Service Poland Sp. z o.o. - established new subsidiary EnergiaOK Sp. z o.o. Both companies own 50% of the EnergiaOK Sp. z o.o. shares. The establishment of new subsidiary is related with the possible business development in Poland.

On 30 June 2014, the transaction of 100% shares sale of UAB Baltijos liftai, registration no. 302496587, was completed. The value of the transaction was LTL 3.6 million (EUR 1.04 million), including the dividends paid. The shares were purchased by private persons from the Republic of Latvia. The Group has accounted profit of LTL 1.4 million (EUR 405 thousand) from the transaction.

## 12. SUBSEQUENT EVENTS

Negotiation on 100% of the UAB Rolvika shares acquisition is ongoing by the Company. On 16 of July, 2014, the application for authorization of transaction was submitted to the Competition Council of the Republic of Lithuania. The Company has no binding agreements regarding this transaction at the time of issuance of these financial statements.

On 22 July, the Company through its subsidiary acquired 100% shares of UAB Mūsų butas, which renders residential facility management services for 91 thousand sq. m. of multi-household in Šiauliai city. Value of the transaction is LTL 907 thousand. The main UAB Mūsų butas activity is administration of dwelling-houses.

On 28 July, the Company's subsidiary in Poland - City Service Polska Sp. z.o.o. - became the sole shareholder of EnergiaOK Sp. z.o.o. and also increased its authorized capital until PLN 1.1 million.

On 5 August, the Company established new subsidiary - UAB Pastatų priežiūra, legal entity code 303363198. Establishment of the company is related with the possible business development in Lithuanian market.

#### 1.3. KEY EVENTS

#### **JANUARY**

The Company, through its subsidiary, acquired 100% shares of City Service Grupa Techniczna Sp. z.o.o. The value of the contract is PLN 5 thousand. At the moment City Service Grupa Techniczna Sp. z.o.o. renders technical maintenance services in Poland.

#### FEBRUARY - MARCH

The company signed an agreement on sale of UAB Ecoservice shares. On 31<sup>st</sup> of March 2014, share transfer transaction was closed, after Competition Council authorized the transaction and other conditions of the transaction were fulfilled. Value of the transaction is LTL 56.6 million (EUR 16.4 million). Shares of UAB Ecoservice are transferred to UAB AWT Holding. Control and controlling interest of the later shall belong to 75% share owner BaltCap Private Equity Fund II, with remaining 25% shares in Company's possession

#### **APRIL**

Riga City Service won another facility management tender in Latvia. The company was entrusted with the task of managing 129 state owned buildings. Riga City Service takes case of the police and fire department's facilities and state border guard service locations by maintaining the facilities' engineering systems and providing emergency services 24/7. The contract has been signed for the period of two years, the amount of the contract is more than EUR 98 thousand.

Considering the structural changes in Poland operating market subsidiaries, as well as the fact that the subsidiary Cleaning Partner Sp.z.o.o. had undisclosed financial obligations to employees, 100 percent of Cleaning Partner Sp.z.o.o shares have been sold.

On 25 April 2014, continuing the process of unbundling the activities, the cleaning activities from UAB Naujamiesčio būstas have been transferred to separate newly established legal entity. Cleaning activities from UAB Naujamiesčio būstas were transferred to UAB Miesto valymas (the Group owns 100% of shares), legal entity code is 303297727.

The Ordinary General Meeting of the Shareholders' meeting was held The shareholders approved the audited financial statement for the year 2013, distributed the Company's profit for the year 2013, a new member of the Board was elected. Shareholders also approved Ernst & Young Baltic UAB, company code 110878442, as an audit company for the performance of the audit of the Company's consolidated financial statements for the year 2014 and for the evaluation of the Company's consolidated annual report. The meeting has also established the payment conditions for audit services. During the meeting the Company decided to purchase its own shares and to withdraw from activities in St. Petersburg and Stavropol.



#### MAY

Company through a subsidiary acquired Administraciones Santa Pola S.L., that manages 211 thousand sq. m. of residential facilities in Alicante province, in Spain. Revenues of acquired company were EUR 115 thousand in 2013, and subcontracted turnover reached EUR 1.4 million. The company was acquired for EUR 90 thousand.

#### **JUNE**

The transaction of 100% shares sale of UAB BALTIJOS LIFTAI, registration no. 302496587, was completed. The value of the transaction was LTL 3.6 million (EUR 1.04 million), including the dividends paid. The shares were purchased by private persons from the Republic of Latvia.

#### **NEWEST EVENTS**

#### **JULY**

The company, via its controlling subsidiary, purchased Mūsų Butas UAB, servicing 91 thousand sq. m. of apartment buildings in Šiauliai district. The amount of transaction was LTL 907 thousand. The company's principal area of activities is administration of dwelling houses.

The Group's subsidiary City Service Polska sp. z o.o in Poland became the sole shareholder of EnergiaOK sp. z o.o. and increased the authorized capital up to PLN 1 100 000.

#### **AUGUST**

The company's subsidiary established Pastatų Priežiūra UAB, legal entity registration number 303363198. The establishment of the company is related with potential expansion in Lithuanian market.



#### 2. ACTIVITIES IN LITHUANIA

#### Apartment buildings maintenance

Maintenance of apartment buildings remains the most important area of the Group companies' activities on the Lithuanian market. The quality of the provided services and customer care was further improved and developed.

During the first half of 2014 the Group companies continued to implement the heat saving measures in apartment buildings according to the "5 steps heat saving programme".

Great attention was dedicated to the Mano būstas facility maintenance standard, which was introduced last year and which ensures the overall maintenance of a building: impeccable functioning of engineering equipment, efficient use of energy resources, quick response to emergency situations 24/7 and smaller dwelling maintenance costs.

During the first half of the year the number of unique visitors of self-servicing portals grew significantly. Compared to the same period of the previous year, the growth exceeded 25 per cent and reached more than 30 thousand visitors per month. In addition, the community portals in the social networks, administered by the Group companies, have been getting more and more popular.

A Group company Mano būstas continued implementing apartment building renovation projects according to the JESSICA programme - at present 170 apartment buildings participate in the programme, real renovation works are in progress in 5 buildings, 34 tenders for construction works have been announced.

At present the total area of apartment buildings, maintained by Mano būstas in Lithuania exceeds 8.4 million sq. m.





#### Commercial facility management

The Group companies continued to strengthen their positions in the area of management of commercial and public facilities. The customer base was extended - about 40 new contracts and agreements were signed. A good deal of the contracts is of exceptional significance, dealing with the objects, requiring specific and especially highly qualified service: airplanes maintenance centre in Kaunas, buildings of religious purpose, Rupert Art and Education Centre in Vilnius.

During the first half of 2014 the total area of the commercial, industrial and public facilities, maintained by the Group companies grew up to 3.2 million sq. m.

This year the Group companies commenced providing complex facility management services to the following companies: BIOK, Eika, Profista, Fresh Market, Lesto, Girteka, Vilnius International Airport, etc.

In the second half of the year the Group companies are going to continue to expand the customer base, dedicating especially great attention to implementation of energy efficiency services in different facilities, maintained by the Group. During the last year, more than LTL 6 million was saved at the objects, in which energy saving solutions had been implemented.



#### **Security services**

The Group company Mano Sauga increased the number of supervised objects and signed several important new contracts. The company commenced provision of security services to Business Centre 2000 and shopping centre Flagman.

The Group company supervises 2800 objects and, in the second half of this year, plans to increase their number up to 3000.

The Group company provides security services to natural persons and legal entities and services residential, commercial and public facilities. The security services package includes video surveillance, patrolling and technical maintenance. In addition, individual security solutions are offered.

Mano Sauga is going to continue dedicating significant attention to new and innovative security solutions and will actively develop the video surveillance services.



#### Territories maintenance and cleaning

The Group company Mano aplinka continued its active development by increasing the sales of services. In the first half of the year the company won the tender for territory maintenance services, announced by the Directorate of the State Cultural Reserve of Vilnius Castles and signed the contract for the time period of 12 months.

The Group company won the tender for maintaining the territories during the events of the Song Celebration.

The company expanded the number of maintained apartment buildings' staircases. Active sales were performed in Klaipėda, Kaunas, Šiauliai and Biržai. The company invested into acquisition of new equipment and expanded the range of its services.

In the second half of the year the company is going to continue active expansion in the area of cleaning of apartment buildings' staircases and territories, improve the quality of cleaning of commercial facilities and maintain the objects, administrated by its subsidiaries.



## Elevators maintenance and renovation

The Group companies increased the volumes of elevators maintenance and renovation activities - the companies Baltijos Liftai and Šiaulių Liftas increased the number of serviced elevators from 1354 up to 1481.

The segment of services, relating to installation and modernization of elevators was strengthened - the companies installed 20 new elevators and 26 lifting devices, and performed a partial modernization of two equipment units.

In the first half of the year the Group companies commenced providing lifting equipment maintenance services to the company Palink, which owns IKI supermarkets throughout Lithuania.

The company Šiaulių Liftas for the first time manufactured its own product and exported it to Latvia.

In June the transaction of sales of 100 per cent of stock of the Group company Baltijos Liftai was finalized. After completing the transaction, starting from 30 June, City Service and its subsidiaries are no longer engaged in elevators maintenance activities.



## 3. ACTIVITIES IN POLAND

When strengthening its positions on Poland's market, the Group commenced providing new facility maintenance and repair services. For this purpose a new company City Service Grupa Techniczna (CSGT) was launched.

At present CSGT administers apartment buildings, as well as objects of private, commercial and public sector, the total area of which is more than 212 thousand sq. m.

The company Zespół Zarządców Nieruchomości (ZZN), acquired by the Group in 2012, continued increasing the area of maintained facilities, which, during the first half-year, grew almost by 207 thousand sq. m.

The main area of activities of ZZN in Poland is administration of apartment buildings and production and supply of heating.

At present the total area of facilities, maintained by the Group companies reaches 9.4 million sq. m. In the second half of this year the Group companies plan to continue their organic development, offer cleaning services and engage in retail sales of electric energy.





## 4. ACTIVITIES IN LATVIA

The Group company Riga City Service continued cooperating with Latvia's state enterprise Latvenergo. The company is going to continue maintaining the engineering systems in all of Latvenergo's facilities. In the first half of the year the Group company commenced providing ventilation and air conditioning systems maintenance services to Latvia's State Supply Agency. The area of maintained facilities is 100 thousand sq. m.

This year the company took an important step, by commencing provision of maintenance services to apartment buildings, which will be the priority area for the second half-year. The company plans to significantly increase the number of serviced apartment buildings.

At present the area of facilities, maintained by Riga City Service reaches 615 thousand sq. m.





# 5. ACTIVITIES IN RUSSIA

In the first half of the year the Group companies extended the scope of their activities in Russia and signed long-term contracts for technical maintenance of commercial facilities. The first customers were the owners of a logistics terminal and business centre, the total area of maintained commercial facilities amounts almost to 85 thousand sq. m.

At present the Group companies service apartment buildings in six administrative areas of Russia. The total area reaches 2.98 million sq. m. and, during the half-year, increased by 5000 sq. m.

Starting from 1 September 2014, the Russian Federation is going to adopt legal acts, foreseeing licensing of the apartment buildings administration activities. All the active administrators will have to obtain the licence till the middle of 2015.

The post-legislative acts, establishing the procedure of licensing, are going to be adopted before the entering into effect of the law. It is forecasted that the new procedure will increase the business administration costs and reduce the competition on the market. The apartment buildings administration market in Saint-Petersburg is viewed as an especially stable one therefore no significant adverse effect on the Group subsidiaries' activities as the result of licensing is expected there.

In the second half of the year the Group companies plan to continue the organic expansion of their activities and attract new customers both in the apartment buildings and commercial facilities segments.

In order to ensure cost-efficiency and improve quality of the services, the Group companies continue successful implementation of the LEAN processes.





## 6. ACTIVITIES IN SPAIN

During the first half of 2014 the Group continued its active expansion and, in May, acquired the company Administraciones Santa Pola S.L., which services about 211 thousand sq. m. area of apartment buildings in the Alicante region. In 2013 the revenues of the purchased company reached EUR 115 thousand, the turnover of managed contractors amounted to EUR 1.4 million. The company was purchased for the amount of EUR 90 thousand.

The Group company signed several new contracts and commenced maintaining Spain's radio and television headquarters as well as the police department's buildings.

The LEAN solutions are further actively implemented within the company - especially large attention is also going to be dedicated to this direction in the future. The most important priority is involving the managers and other staff into the LEAN processes.

In the second half of the year the Group company plans to continue its active expansion on the market of maintenance of commercial facilities and apartment buildings. In addition, new companies are planned to be acquired.

At present the total area of the maintained facilities reaches 6.5 million sq. m., the area of cleaned objects and maintained territories - more than 1.4 million sq. m.

The Group companies, operating in Spain, are engaged in maintenance of commercial, public, industrial facilities and apartment buildings, and also provide cleaning and territories maintenance services.





## 7. INCREASING OF PERFORMANCE EFFECTIVENESS

The LEAN solutions are continued to be implemented throughout the Group. In the first half of the year the amount of personnel, involved in the processes was 10 per cent larger than last year.

The activities efficiency improvement in the Group companies, operating in Lithuania resulted in the situation where the indicator of residents' satisfaction with the companies' activities is growing for five years in a row. Such data was revealed by the traditional survey of the residents' opinion, which was performed in the first half of the year.

At present the LEAN division, established within the Group is one of the largest in Lithuania, which shows that especially great attention is dedicated to the activity improvement processes.

The LEAN methods have been successfully implemented not only within the Group. The Group's experts have been sharing the good practice with their customers, such as the shopping and entertainment centre OZAS and sports clubs network Impuls.

The Kaizen ideas are getting more and more popular throughout the Group. The employees are eager to provide suggestions on how to improve the activities within their companies. Compared with the first half of 2013, this year the number of Kaizen ideas grew by almost 60 per cent and reached 1286.

In the next half-year the Group companies are going to continue implementing new and improving the existing LEAN solutions not only in Lithuania, but also in Spain, Poland, Latvia and Russia.





# 8. EMPLOYEES

The Group's values are continued to be communicated throughout the companies. The Values Game was developed by the employees in cooperation with consultants from the company Implement Inscape. The game not only helps the employees to remember the company's values and observe them, but also contributes to development of closer relations and allows the managers to understand their subordinates better and vice versa.

In the first half of the year the project with the works superintendants, working in Kaunas region was commenced. The aim of the project is to assist the superintendants to set the everyday activity indicators, which they would discuss with the technical staff during everyday morning meetings. The personnel really appreciated the project, since each employee gets a possibility to see his/her coworkers' progress, discuss the problems, arising during the working processes and suggest solutions.

This year the training of facilities administration managers is further continued. In the first half-year the employees developed their qualifications by improving their knowledge of engineering systems, sales and customer care.

In addition, a training programme for works superintendants was developed. The employees are going to be trained to use the internal systems, improve their computer literacy and deepen their knowledge in the area of management.

# 16.1. REPORTING PERIOD OF THE INTERIM CONSOLIDATED REPORT

This interim Consolidated Report is prepared for the period of the six months of 2014, ended on 30 June 2014.
